The bids for the above referenced project were opened on June 3, 2025. A copy of our bid tabulation is enclosed for your information and review.

A total of three (3) bids were received for this project. The low bid was submitted by RMG Custom Metal LLC in the amount of \$238,736. We have previous working experience with RMG Custom Metal LLC and have discussed their bid and construction schedule with them. We feel their bid is a true representation of costs to complete this project and that RMG Custom Metal LLC is qualified to complete the project.

We recommend that the Town of Bethany pass a resolution: **"Accepting the Base Bid received from RMG Custom Metal LLC in the amount of \$238,736".**

We have also enclosed the Notice of Award which will need to be signed and returned to our office. The Notice of Award will then be forwarded to the Contractor, along with copies of the Agreement and other documents for their execution. When returned by the Contractor, the Agreements will be sent to you for signature. This process generally takes two (2) weeks.
